

• Purpose

- Build depth of understanding for your story about Information Policy and Law (disinformation, misinformation, and fake news)
- Better use the Foundation Principles
- Preparation
 - Identify, consume and evaluate articles, videos, websites, etc on our topic
 - Please arrive to the caucus prepared to tell your story in 5 minutes (your values and beliefs impacting your Information Policy and Law thinking ... as shaped by your experiences and influencers)
 - Please arrive prepared to discuss your views on the issue including your issue definition, your desired vision and outcomes, and your suggestions for actions and paths taken



Session 2 – The Caucuses on U.S. Information Policy and Law

Related ONLY to the topic (split time to cover) EACH of you are asked to:

- Share your Experiences and Values identify and share your top 2-3 values and beliefs, events and influencers (each person, then summarize for Caucus)
- Declare your desired Vision and Outcomes identify and share your desired 5 year single vision with outcomes (each person, then summarize for Caucus)
- Suggest your Paths to get to your vision suggest means to attain the desired outcomes (each person, then summarize for Caucus)

The team civilly discusses the individual inputs and prepares a Caucus-wide summarization of their collective story:

- Focus on common ground (Values, Vision, and Paths) within their Caucus Team
- Prepare to share the Caucus summarized view as a team






